

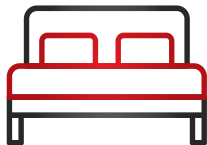

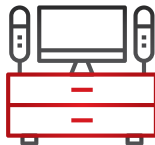
## Insuring your contents is easy with TenantCover

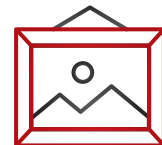
- Cover for contents against theft or damage by fire, explosion, storm and flood.
